As many of you have seen, we are cutting back due to lack of funds. We no longer send out the 12 page compiled list of Pen Pal sources. The Resources List is up to 52 pages with over 650 listings. It now requires a 6" X 9" envelope with \$.91 postage. Both lists have displayed the effect of lack of support as we watched one ministry after another close their doors.

Many of the inmates that we mail to, try to help with stamps and some monetary donations. Receiving the "self-addressed stamped envelope" (S.A.S.E.) is a saver of our time as well as money. What we would really like to see is churches financially supportive of the prison ministry. Relatives and loved ones of inmates joining in to help support the cost of publications.

The following Journey Journal is from Chaplain John Sayers. Right in agreement with what Bob and the volunteers of M.O.M. try to express daily. Bob has added to John's writing and hopefully enhancing the document. Please read with the humor intended.

#### THE CHURCH IS THE BRIDE OF CHRIST, an Urgent Call for Renewal

The title of the journey comes from Chuck Swindoll's two books (1) The Bride of Christ, Renewing our Passion for the Church, and (2) The Church Awakening, An Urgent Call for Renewal. I do want to encourage you to get the second book because much of this journey will be based on that book. By the way Chuck bases all his books on THE BOOK.

Some of you may be offended or believe I am truly off base on what I am going to share and it is possible you could be right on both accounts but in this Sundays message I will be starting, that is unless some of you can change my path, on this journey when you get back to me, with...

#### **HOW TO HAVE AN INSTITIONAL CHURCH**

15 Guidelines (but there may be more)

- 1. As soon as you can, pay for a Pastor and staff- Remember this is more important then having a building. I will bring that up later in number 12. Having a paid Pastor and staff will give the message to the people that only the professionals (ordained) are quality for full time service with the Lord. How many pastors do we see that have a full time job that pays well, but still feel they have to tap the church funds to supplement their salaries? Even at the expense of outreach to others?
- 2. Find a charismatic preacher. It would be good if he (sometimes she) would use the Bible as a main text but it is not vital. The bible can be used as a jumping off point, but the preacher does not have to stay with the text. People will come as long as he (sometimes she) is entertaining. A message under 40 minutes would be best. By the way this might be less depending on the church. (a personal note from chaplain John, I may be doing this during this series, but I hope and pray the it will be scripture center)
- 3. The message should be at the end of the service. Remember all that happens before the message is just a lead into the real service, THE SERMON. (note from Chaplain John: At the 1st Christian Church in Porterville they have communion EVERY Sunday, before the sermon. Their reason is the Lord's Supper should be the HEART of our worship not the message and by the way the Lord's Supper is lead my lay people. Boy do they have this wrong, the sermon should be the HEART of the worship and how can one have the Lord's Supper if the ordained minister is not blessing the elements? (Hope you are reading this with humor.)

- **4**. Develop a lively praise Band not hard to find but it is best to have young people and their dress should be torn jeans and if possible they do not have to wear shoes. I have been in so many churches that the dress is casual (not a problem in itself) but then find the members and even the pastor/staff dressed much nicer for their secular job. Do we give our best or just what's left? The message of the song is not all that important, just make sure it centers in us, not God. "Jesus Loves ME" is still a classic. It is also good to repeat over and over and over again the praise of a song as long as it has a good beat. For those over 50, songs should be from the Hymn book.
- 5. Place the chairs (not pews) in rows facing front. Remember the center of worship should be on those leading the service. It also gives the strong message that only the "professionals" can lead in worship. After all you would not want a lay person giving the sermon would you?
- **6**. Make it clear your church is not the typical church. I am not sure how one does this, but it seems to be a message I have been hearing in many worship services but they seem to be the same. *Many times dropping outreach programs makes the church not the typical church. But as more churches drop programs (Sunday night services, mid-week services, jail ministry, homeless ministry, etc, they all approach typical at the other end of the spectrum)*
- 7. Have a children's church, so parents will not have to worship as a family. It is OK to have children with you at the start of the service, but when the real important part of worship takes place, THE SERMON, have the kids leave to have their own baby-sitting (I mean worship) time.
- 8. Keep the center of the church on Sunday attendance. You can preach about being the church in the community but make sure the real message is about showing up on Sunday. *Make sure the church gets credit and does bows for outreach done by private little groups.*
- **9**. Keep the center of the church on coming to the building, rather than the people going to the community? A good way to do this is to teach the children old sayings like "Here is the church, here is the steeple, open the doors and see all the people". Be careful not to teach "Open the doors and out goes the people."
- **10**. Teach your members to sit in the back and make visitors move to the front. On second thought forget this, members just learn this on their own.
- **11**. HAVE COFFEE ready before, during and after the service-Donuts would be a big pulse. I might even attend this type of church more often.
- 12. MOVE INTO YOUR OWN BUILDING AS SOON AS POSSIBLE. When starting out you may not have the funds to have a building. But, if you follow the above guidelines you will have the people and the finances to have your own building. Then you truly can become an INSTITIONAL CHURCH. You will know you have an Institutional church when the majority of your offering goes to paying for the staff and maintaining the building.
- **13**. Make sure all the board of directors and staff are friends or relatives. That way there will be no conflict with church plans.
- **14**. Make sure to keep the budget and income/expense reports away from the congregation. If spending habits are known, it will only confuse the congregation,

which might cause questions to arise. Don't worry about a fiduciary responsibility to the congregation.

Last (but I'll bet there are more)

15. Preach grace only. Make sure to keep a lot of decisions being made (salvation, baptism, etc.) even if the individuals are not willing to change, and continue in sins such as fornication, drug addiction, etc. I have been in many churches that have individuals living in sexual sins and they do baptisms of these individuals and even put them in positions of ministry and authority. Remember that salvation and baptism have no pre-requisites.

Remember the goal should be to bring people IN not have them go OUT. Do not ever preach a message that those living in sin might take offensive, or worse yet, personal.

If you are in a "feel good" church, perhaps you are in an institutional church that preaches on not being the "typical church," only to see it is exactly like the others.

Although this was written in a humorous approach, the saddening truth is these examples are what many look for. A comfortable ministry, with staff paid to make you feel good, without any change in our lives on our part. You look at the individuals in these churches and ministries and they continue in the same sinful lives and preach how great Grace and Mercy are, but forget about the emphasis on **REPENTANCE**.

Bob has registered in 18 Bill Glass events, going as far as Grand Rapids Michigan to minister in Ottowa County Jail and Mel Trotter Rescue Home. Bob and Linda have also ministered out of state in Oregon and Arizona on numerous occasions. In California, we have ministered in West Valley Detention Center, Corcoran State Prison, Avenal State Prison, Chino State Prison, California Institute of Women, Glen Helen Rehabilitation Center, Wasco Prison, North Kern State Prison, Kern Valley State Prison, S.A.T.F., Soledad State Prison, Fresno Juvenile Facility, Folsom Prison, Alameda County Jail, Bob Wiley Detention Facility (11 years), Tulare County Pre-Trial, Tulare County Men's Correctional Facility, Pleasant Valley State Prison, and probably many not brought back to memory.

As Bob and staff evaluate the direction of M.O.M., we have let the brown cards (volunteer clearance) for Avenal State Prison and Corcoran State Prison expire in July 2014. We have been doing Corcoran prison with monthly services for about 11 years, and Avenal for approximately 3 years. Our brown card clearance for California Men's Colony (C.M.C.) will be up for renewal in May 2015. We have been offering services to C.M.C. for 3 years.

The response was immediate. A number of legislators walked out during the prayer in protest. In 6 short weeks, Central Christian Church, where Rev.
